

Herding Clinic with Tenley Dexter

Pre-Entry only. Limited number of working spots (dog/handler teams). Limited auditor spots available (w/o dog). This is a 2-day working clinic.

Tenley has experience working with a wide variety of herding breeds & handlers of all levels. She is an exceptional teacher & stock dog handler, teaching students to work with their dogs using simple consistent communication to develop a teamwork approach to working their dogs.

Mixed breed hair sheep, and ducks available. There are several different sized working areas, including an indoor arena.

Registration: Registration is by **Pre-Entry Only**. **Opening date, March 1st**. Please fill out the attached entry form, and provide proof of rabies vaccination and check (payable to Outback Farm) mail to: Outback Farm at the address above. You will receive an email confirming receipt of registration.

Cost: \$175/ working spot for both days. One day working spot \$100. Auditor registration is \$50 per day. If you register for a working spot, but are unable to attend, your money will be refunded to you if your spot can be filled.

Restrictions: This is a private farm, please be considerate. Dogs must be on leash or penned/crated when not working, and must not be allowed to bark continuously, harass the livestock or interfere with the team that is currently working. Please follow all farm rules.

Other:

- **Food:** Snacks, drinks & lunch will be available during the day, supplied by the farm.
- **Water/pools** will be available for cooling dogs off.
- Please bring your own shade, chairs and crates.
- Dress in layers & wear appropriate footwear.

Directions:

- **From the North:** Take Rt.84 to Milford, PA exit (Rt. 6 & 209 S). Follow thru Milford, turn Left onto Rt. 206 S, & go over Delaware River into NJ. Follow Rt. 206 S for approximately 20 minutes. Pass Dairy Queen, & Luk Oil Gas station, turn right onto Union Turnpike (Rt. 630 W). Take first left onto Stempert Rd. & farm is #18 on the left. Split rail fencing around property.
- **From the South:** Take Rt. 15 N, to Rt. 206 N. At Ross's corner (Exxon, Chatterbox drive in food) go through 4 more traffic lights & take 2nd left onto Union Turnpike. Follow above.

About the Instructor: Tenley Dexter has owned Aussies for almost 4 decades & has trained & trialed multiple dogs including WTCH Beauwoods Kobi HAsd, WTCH C Hangin 5 Annies Breeze HICsd, WTCH Makin 8 Tuff E Nuff HICs, WTCH Makin 8 Seeing Stars HICs, WTCH Makin 8 Kate (kelpie), & is currently trialing Makin 8 Skat Kat, Most Promising Dog at the ASCA CO Natls & both Pre Trials, & J Bar D Makin 8 Snip, HIT Sheep Dog at the CO ASCA Natls Pre Trials. Tenley has bred, trained & earned Champions & Reserve Champion honors in Cattle & Sheep with her dogs at the ASCA Stock dog Finals. She trials in all venues including, AKC, ASCA, AHBA, ASTA & USBCHA.
