ASCA Stockdog Rules – Section 5.5 – Waiting List - Fees will be refunded to the original entrant by the host club before close of entries only if a replacement dog is entered in place of the absent dog. Once entries close, entries do not need to be refunded by the Host Club.

Entry Fees:

*Cattle \$35 pre-entry \$40 day-of-trial

*Sheep \$30 pre-entry \$35 day-of-trial

*Ducks \$25 pre-entry \$30 day-of-trial

All Junior class entries are 1/2 price regular entries.

*Entries limits to 40 runs per day. Course B.

***Handler's meeting at 7:30 am** and classes will begin immediately following the handler's meeting starting with cattle, then sheep and finally duck runs.

*Prizes offered: HC Aussie, HC Other Breed, HIT Jr.

*In the case of a dog injuring stock, owner will pay all vet fees and/or replacement value of the stock (Cattle \$700, Sheep \$150, Ducks \$25) and any disposal fees if required.

*Non ASCA registered dogs must acquire a "tracking number" if you wish to earn titles through ASCA.
